NOTICE OF PENALTY

British Baseball Federation (BBF) reference: Incident Sunday 12 September 2021 – London Mustangs vs Brighton Brewers

Date: 03/11/2021

1. INCIDENT

1.1. Ejection from the Single A Final on 12th September 2021.

SUMMARY OF INCIDENT

- 2.1. You were playing for London Mustangs when you were called out on strikes by the umpire, David lones.
- 2.2 You reacted to the call by throwing your bat down and mumbling as you walked back to your dugout.
- 2.3 The umpire ejected you for throwing equipment in reaction to his call.

3. ENFORCEMENT PROCESS

- 3.1. It has been determined that I can deal with this incident as League Commissioner following the Disciplinary Table in the BBF Handbook 2021.
- 3.2. You have the right to respond to my initial findings within seven days of the date of this notice. If you need any further time to respond please do so before the seven-day period has expired.
- 3.3. Appendix 1 to this Notice is the umpire's report for your reference.

4. DISCIPLINARY CONSEQUENCE

- 4.1. The consequence considered after reviewing the umpire's report and as it is your first offence, is a £30 fine. This is detailed in the Seniors' Handbook.
- 4.2 There is a shortage of umpires in British Baseball. Players, coaches, and team managers should always treat umpires with respect, regardless of their opinion on the umpire's performance in the game. Please see the 'NO EXCUSE TO ABUSE' section on our website here:

4.3 Please note that in this instance you would usually receive a suspension for not leaving the field/dugout/sidelines. However, as the umpire can not definitely give an answer as to where you were after your ejection, I am not enforcing said suspension. For future reference, after a participant is ejected, they must leave the field/dugout/sidelines and shouldn't be seen for the rest of the game.

5. APPEAL

- 5.1. You have the right to appeal this decision before the date of your next scheduled game.
- 5.2. Any appeal must be made in writing by sending your email to christian.carter@britishbaseball.org and be based on one or more of the following grounds:
- based on incorrect factual findings
- wrongly identified infringements
- the penalty is excessive
- there has been a serious failure to follow the enforcement process and it is unfair or unjust to allow this notice to stand.

5.3 Under the appeal process, different factual findings may be discovered and as a result the penalty determined may change. Any finding showing an appeal was brought without any prospect of success may be taken into account in determining any change to the penalty.
