#### 1. INCIDENT

1.1. Ejection during a AA Postseason game on 11<sup>th</sup> September 2022.

#### SUMMARY OF INCIDENT

- 2.1. You were representing East London Latin Boys in their away team dugout.
- 2.2. You left your dugout to seek clarity on why a call was made.
- 2.3. The base umpire instructed you to return to your dugout.
- 2.4. You did not return to the dugout and instead continued your verbal altercation.
- 2.5. You were ejected from the game for refusing to follow the instruction made by the umpire.
- 2.6. You did not leave the dugout immediately, and only did so when confronted by the TC.

#### 3. ENFORCEMENT PROCESS

- 3.1. The <u>BBF Enforcement Process</u> has been followed.
- 3.2. You have been provided with the umpire's report.
- 3.3. You replied to the Notice of Incident in an effort to justify your actions.
- 3.4. You acknowledged that you questioned the umpire directly regarding a call, which in itself is not appropriate considering you are not the Manager.
- 3.5. You also acknowledged that you did not leave the dugout after your ejection, and provided no worthy reason for you to have remained there.

#### 4. DISCIPLINARY CONSEQUENCE

4.1. As it is your **first offence** this season, the consequence determined is **a £30 fine and a two (2) game suspension.** This is detailed in the Seniors' Handbook as the mandatory fine for a first offence and the suspension is for actions detailed in ID 22 and ID 35 of the disciplinary matrix.

### 5. APPEAL

- 5.1. You have the right to appeal this decision (£50 fee) before 6th<sup>th</sup> February 2023 at 5pm.
- 5.2. Any appeal must be made in writing by sending your email to <u>senior.leagues@britishbaseball.org.uk</u> and be based on one or more of the following grounds:
- based on incorrect factual findings
- wrongly identified infringements
- the penalty is excessive
- there has been a serious failure to follow the enforcement process and it is unfair or unjust to allow this notice to stand.
- 5.3 Under the appeal process, different factual findings may be discovered and as a result the penalty determined may change. Any finding showing an appeal was brought without any prospect of success may be considered in determining any change to the penalty.

#### 6. SUMMARY

- 6.1. If you accept the penalty, please confirm this by replying to the email to which this Notice was attached, and you will be provided with bank details to pay the fine.
- 6.2. If you wish to appeal, please do so before the date of your next scheduled game as explained in 5. above.
